


**Regulations made under Rule 57 of the Parliamentary Elections Rules
1983 as applied to elections to the Northern Ireland Assembly.
Conditions for the inspections of Documents**

The Returning Officer, in exercise of the powers conferred on him by Rule 57 of the Parliamentary Elections Rules as set out in Schedule 1 to the Representation of the People Act 1983 and applied, with modifications, to elections to the Northern Ireland Assembly by Article 3(1) and Schedule 1 to the Northern Ireland Assembly (Elections) Order 2001, with the approval of the Secretary of State in respect of regulation 4 hereof, hereby prescribes the following conditions for the public inspection of any of the documents relating to elections to the Northern Ireland Assembly held on 7 March 2007:

1. Inspection shall be allowed only by prior appointment with the Electoral Office for Northern Ireland. Applications in respect of documents relating to the constituencies specified in column 1 of the attached schedule must be sent in writing to the address specified in column 2.
2. Any document to which these conditions apply and which is open to inspection pursuant to Rule 57(2) may be inspected at the Electoral Office specified in the schedule on working days between 10.00am and noon and 2.00pm and 4.00pm.
3. Inspection may take place only in the presence of an official of the Electoral Office for Northern Ireland.
4. Where copies of or extracts from documents are supplied the following fees shall be charged and must be paid in advance:

Handling charge for registers or parts thereof	£9.00
Photocopying per A3 page	£0.40
Photocopying per A4 page	£0.35
Packaging	£0.55
Postage	at cost
