


**UK PARLIAMENTARY ELECTION 2024****NOTICE OF ELECTION**

1. An Election is to be held for a Member to serve in Parliament for each of the eighteen Northern Ireland Constituencies. In the event of a contest, a poll will be taken on **Thursday 4 July 2024** and the hours of the poll will be from **7.00am to 10.00pm**.
2. Nomination papers may be delivered to Returning Officer (RO) staff at the nomination venues listed below between **10.00am and 4.00pm on Tuesday 4 June, Wednesday 5 June, Thursday 6 June and Friday 7 June 2024** but not later than **4.00pm on Friday 7 June 2024**. They may only be delivered by the candidate, proposer or seconder or by the election agent if the agent's name and address has been given to the RO.
3. Nomination papers may be downloaded from the Electoral Office website **www.eoni.org.uk** or obtained during normal office hours or by telephoning the Helpline on 028 9044 6680.
4. The sum of £500 must be received before the deadline for receipt of nominations at **4.00pm on Friday 7 June 2024** deposited either centrally with the Finance Officer or with the RO nominated staff at the venues below during the time for the delivery of nomination papers. The deposit may be paid only in legal tender, by bankers draft or by CHAPS (apply to the Finance Officer for account details).
5. Applications to vote by post or proxy are available to download from the Electoral Office website **www.eoni.org.uk** or by contacting the Helpline on 028 9044 6680. Completed applications must reach the Electoral Office, St Anne's House, 15 Church Street, Belfast, BT1 1ER by **5.00pm Friday 14 June 2024**, except where the application is made on the grounds of unforeseen illness. Any such application must be received not later than 5.00pm on Wednesday 26 June 2024 at the address just mentioned.
