Useful information

Use this form to register to vote or update your details (if your name, address or signature has changed). Remember that this form contains personal information which could be of interest to criminals. You should return it only to the Electoral Office for Northern Ireland.

You can register to vote if you are:

Resident in Northern Ireland and will be aged 17 or older ordinarily before 1st December on the year of application (please note you will not be able to vote until you are 18).

You must also be either:

A British, or Irish **OR** A Commonwealth citizen who has leave to enter or remain in the UK or who does not require such leave **OR** An eligible European Union citizen.

Immigration status: If you are a European Union citizen from Austria, Belgium, Bulgaria, Croatia, Czech Republic, Estonia, Finland, France, Germany, Greece, Hungary, Italy, Latvia, Lithuania, Netherlands, Romania, Slovakia, Slovenia or Sweden you will need to complete the immigration status section.

Tick yes if one or more of the following applied to you on or before 31 December 2020 and has continued without a break:

- Settled or pre-settled status under the EU settlement scheme, except if you applied as a joining family member
- Indefinite or limited permission to enter or stay in the UK, Channel Islands or Isle of Man
- Resident in the UK, Channel Islands or Isle of Man but exempt from immigration controls
- We need one form for each person.
- You must give your date of birth and sign the form yourself no-one else can sign it for you.
- If you cannot give us your nationality or national insurance number you must tell us why.
- If you have changed your name (for example because you have got married) it would be helpful if you give your old name to help us identify you. Otherwise we may need to request additional documentary evidence.

Why do I need to register?

- You can only vote at elections if your name is on the register of electors.
- The register may be used by people to decide whether or not to give you credit. If you are not on the register, you may find it difficult to get a loan, to open a bank account or get credit.

When we receive the form, we will check the information you have given. We will change or add your details on the register within six weeks if we accept your application. We will send you a letter of confirmation which will also give the date the changes come into effect. If we need more information we will contact you. We may ask for proof of the information you have given.

The full and edited electoral registers

We publish two registers:

The edited register. The edited register is available for general sale and can be used for any purpose. It can be bought by any person, company or organisation and can be used for commercial activities such as marketing. If you do not want your details to appear on the edited register tick the 'Edited Register' box.

The full register lists the name and address of everyone who is entitled to vote. By law, certain public organisations and people, including politicians, can receive the full register. Anyone can look at it but it is a crime to supply or use the information for purposes other than those allowed by law. Credit reference agencies can use the full register to check your name and address if you are applying for credit.

The electoral identity card

You should only apply for an Electoral Identity card if you do <u>not</u> have a passport/driving licence or another form of identification used to vote (e.g. see https://www.eoni.org.uk/Vote/Voting-at-a-polling-place).

Do **not** use this form to apply for an Electoral Identity card. You should request a separate application form by ticking the box on this form. If your electoral registration is successful we will send you an application form in the post.
