Application for Permanent Proxy Vote – Employment



If you, or your spouse/civil partner has employment, service or occupation that means you are unable to go to your Polling Station to vote at elections, you can use this form to apply for a **permanent proxy vote**. This is where you appoint someone to vote on your behalf at your Polling Station on election day.

You must be registered to vote to apply for a proxy vote. If you are unsure if you are registered to vote, go online and check at www.eoni.org.uk/can-i-vote

1 Complete your personal details. You can get your National Insurance Number online at www.gov.uk/lost-national-insurance-number. Providing contact information is optional – either a telephone number or an email address.

Your information will be checked with the electoral register and, if inaccurate your application will be rejected.

2 If you went online to register to vote, then you **MUST** provide your **Digital Registration Number (DRN)**. Most people register in this way - you should check at www.eoni.org.uk/DRN

If you do not know your DRN, you can request it online at www.eoni.org.uk/DRN or find it on your letter of electoral registration confirmation.

If your application is rejected on these grounds, we will treat it as a request for your DRN and send it to you.

3 Provide details of the person you wish to appoint as your proxy. Your proxy must be registered & entitled to vote at the election and will need to attend your Polling Station to vote for you. A person can only be appointed as a proxy for 2 electors living in Northern Ireland at the election.

4 Sign & date the form to verify the information you provided is correct. If you cannot sign the form due to a disability or an inability to read/write, someone else must witness & sign your application.

5 You need to state if you are making this application based on your employment or on your spouse/civil partner's employment.

You must also provide a reason why this employment means you need a proxy vote.

6 You must have the form attested or supported by another person to verify your reason for a proxy vote. If your application is not attested it will be refused.

Declaration A must be completed if you are employed by a company/employer.

Only

- the employer; or
- another employee of the company with delegated authority to attest these forms

can complete this for you.

That person must know you (or your spouse or civil partner) are currently employed by the company.

Declaration B must be completed if you are self employed.

Only a person who knows you (or your spouse or civil partner) are currently self-employed can complete this form for you.

For Declarations A & B that person must also satisfy the other criteria stated.
