If you, or your spouse/civil partner undertake employment, service or occupation that means you are unable to go to your Polling Station to vote at elections, you can use this form to apply for a permanent postal vote. This is where your ballot paper is posted to you before election day, for you to complete & return by post. Postal votes are sent out up to 2 weeks before election day.

You must be registered to vote to apply for a postal vote. If you are unsure if you are registered to vote, go online and check at www.eoni.org.uk/can-l-vote

Complete your personal details. You can get your 5 You need to state if you are making this National Insurance Number online at www.gov.uk/lost-national-insurance-number. Providing contact information is optional – either a telephone number or an email address.

Your information will be checked with the electoral register and, if inaccurate your application will be rejected.

If you do not know your DRN, you can request it online at www.eoni.org.uk/DRN or find it on your letter of electoral registration confirmation.

If your application is rejected on these grounds, we will treat it as a request for your DRN and send it to you.

Sign & date the form to verify the information you provided is correct. If you cannot sign the form due to a disability or an inability to read/write, someone else must witness & sign your application.

6 You must have the form attested or supported by another person to verify your reason for a postal vote. If your application is not attested it will be refused.

Declaration A must be completed if you are employed by a company/employer. Only

can complete this for you.

That person must know you (or your spouse or civil partner) are currently employed by the company.

Declaration B must be completed if you are self employed.

Only a person who knows you (or your spouse or civil partner) are currently selfemployed can complete this form for you.

For Declarations A & B that person must also satisfy the other criteria stated.
