Electoral registration form for a British or eligible Irish citizen* living overseas

You need to be on the electoral register to vote in elections and referendums. If you are a British or eligible Irish citizen* living outside the United Kingdom, you can apply to be an overseas voter provided you are of voting age and were registered to vote or lived in Northern Ireland in the past.

As an overseas elector, you are eligible to vote at elections for the UK Parliament. You cannot vote in local elections or elections to the Northern Ireland Assembly. This form will allow you to register as an overseas elector for **up to three years**. We will write to you before your registration expires to remind you to renew your registration.

* An 'eligible Irish citizen' is someone who was born in Northern Ireland, who is an Irish citizen and also qualifies as a British citizen (whether or not they identify themselves as such)

How do I register as an overseas elector?

Fill in the registration form. You do not have to give a telephone number or email address but it is helpful in case we need to contact you about your form.

Decide how you want to vote at section 6:

By proxy. If you want someone else to vote on your behalf, you must appoint him/her and provide his/her details. Your proxy must be registered and eligible to vote. A proxy can vote for a maximum of 4 people. No more than 2 of these people can be domestic electors. Domestic electors are voters who are neither overseas voters nor service voters.

In person. (If you are likely to be in Northern Ireland on the date of an election)

Make sure you complete and sign the declaration at section 7.

Electoral Office for Northern Ireland Colby House Stranmillis Court Belfast BT9 5TA There are two versions of the register: the full and the edited version. Your details will appear on the full version of the register, but you can choose whether or not your details appear on the edited register.

The edited register. If you tick the 'edited register' box, your name and address will not appear on the edited register, which anyone can buy or use for any purpose. Any person, company or organisation including 'junk-mail' companies can buy a copy of the edited register for business activities such as marketing.

The full register lists the name and address of everyone who is registered. By law, certain public organisations and people, including politicians, can receive the full register. Anyone can look at it but it is a crime to supply or use the information for purposes other than those allowed by law. Credit reference agencies can use the full register, but only to check your name and address if you are applying for credit.
